



## 2020 Maine Lobster Festival

### Sea Princess Eligibility Guidelines

The Maine Sea Goddess Pageant is open to 20 participants who meet the Maine Lobster Festivals' guidelines, submit a completed application (along with all required Check List Items) mail to:

#### **Application Requirements:**

*Any incomplete applications (or postmarked before Saturday, February 15, 2020) will not be accepted, and will be returned to the applicant. Deadline for submitting applications is Sunday, June 14, 2020. Applications postmarked after June 15th may not be accepted.*

#### **Applicants:**

- Must be a citizen of the United States and a resident of Maine
- Must be a high school (or equivalent GED) graduate
- Be no more than 21 years of age on July 31, 2020
- May only participate in the pageant once
- Must not be, or planning on becoming, pregnant during the pageant or after, if crowned
- Have no past or pending civil or criminal charges exceeding moving violations

#### **Further, as an accepted applicant, a Sea Princess:**

- Is required to volunteer a minimum of four hours before the Festival opens
- Is required to abide by Maine State Laws pertaining to illicit drugs, alcohol, cannabis or any other substance use
- Is expected to mingle on the grounds a minimum of two hours every day wearing appropriate dress, footwear, and sash. (You are an Ambassador for the Maine Lobster Festival and the Fishing/Lobster industry. Be polite and courteous in whatever you do)
- Is responsible to provide their own car (convertible) and driver for the Maine Lobster Festival 2020 parade; however, contact the Coronation Committee for guidance

## **Resignations and/or Grounds for Exclusion or Relinquishment of Titles:**

### **Social Media:**

If you have a Facebook, or other social media account, please be aware of what you are putting on there. **ANY** inappropriate or illegal activities in the form of pictures, behaviors or script on your site by you or others could be cause for relinquishing your title, if crowned.

### **Illegal Activities:**

**ANY** participant found consuming any illegal, controlled, dangerous substances, abusing the use of alcohol, and/or consuming alcohol illegally, will be grounds for review of potential disqualification or title relinquish by the Coronation Committee and Rockland Festival Corporation Executive Board.

**ANY** contestant found to be in violation of Maine State Laws will be grounds for disqualification or title relinquish.

**Any contestant or title holder found to be in violation of any of the above, will be grounds for disqualification or relinquishment of titles at the discretion of the Coronation Committee and Rockland Festival Corporation Executive Board**

- *Any Sea Goddess, Crown Princess or Miss Congeniality who resigns, or is removed from office, may be required to return cash prize award money back to the Maine Lobster Festival treasurer. The Coronation Committee and Rockland Festival Corporation are not responsible for any refunds.*

## **Sea Princess Schedule Requirements:**

Following the application process, selected Sea Princesses will be requested to attend a series of events leading up to the 73<sup>rd</sup> Maine Lobster Festival. These events will be used for judges to get to know the participants, build relationships with other participants, gain knowledge of the Fishing/Lobster Industry that the Sea Goddess represents, and most importantly, HAVE FUN.

It is **HIGHLY RECOMMENDED** that each participant makes every effort to attend all pre-Coronation events that are not listed as a REQUIRED EVENT. This will give participants information needed for potential questions during the Coronation Banquet and to interact with other participants.

### **Pre-Coronation Events/Tours:**

## **Sea Goddess Schedule Requirements:**

The following are requirements that must be adhered to if crowned the Sea Goddess.

### **Concluding the 2020 Maine Lobster Festival Coronation, the Sea Goddess must:**

- Be present, daily, on the festival grounds wearing your crown and sash, according to a schedule that will be provided during rehearsals.
- You will be mingling with King Neptune, Black Beard, and at times the King's Court, having your picture taken, handing out awards to contestant winners and medallions to the contestants of various events such as the Crate Race, Cooking Contest, Cod Fish Carry, Lobster Eating Contest, Baby Crawl and others.

### **Represent the Maine Lobster Festival at the following required events:**

Please give this to the Coronation Chairman prior to the crowning of the new Sea Goddess)

**Crown Princess Schedule Requirements:**

The Crown Princess also has additional requirements that must be met when being crowned Crown Princess. Also, the Crown Princess may need to step in and represent the Maine Lobster Festival and Fishing/Lobster Industry on behalf of the Sea Goddess.

**Concluding the 2020 Maine Lobster Festival Coronation, she must:**

- Be present, daily, on the festival grounds wearing your crown and sash, according to a schedule that will be provided during rehearsals.
- You will be mingling with King Neptune, Black Beard, and at times the King's Court, having your picture taken, handing out awards to contestant winners and medallions to the contestants of various events such as the Crate Race, Cooking Contest, Cod Fish Carry, Lobster Eating Contest, Baby Crawl and others.
